MR. PORTER: We will call Case 1526.

MR. PAYNE: Case 1526. Northwestern New Mexico nomen-
clature case calling for an order extending the Angels Peak-Dakota
Pool.

MR. COOLEY: Mr. Chairman, at the October regular hear-
ing El Paso Natural Gas Company presented a case requesting 320-
acre spacing in Dakota formation in Northwestern New Mexico. At

that time the Commission took the case under consideration and subsequently El Paso moved that any consideration of an extension of the horizontal limits of Angels Peak-Dakota Pool be postponed until such time as there is a final determination regarding their application. As there has been no further determination of that application, I recommend that the case be continued.

MR. FEDERICI: I am Bill Federici of Santa Fe, and on behalf of Kingwood Oil Company of Oklahoma City, Oklahoma, we likewise request a continuance of the hearing until some time after a hearing is had on El Paso Natural Gas' application.

MR. PORTER: Case 1526 will be continued until the Commission has made final disposition of Case 1523.

MR. FEDERICE: If the Commission please, that is also included in this 1547 (e).


MR. COOLEY: That will come up later.
