ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 15, 1958, at Farmington, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 21<sup>st</sup> day of October, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Canyon Largo-Pictured Cliffs Pool, the Otero-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool and the Otero-Gallup Oil Pool, all in Rio Arriba County, New Mexico, to the Aztec-Fruitland Pool, the Bisti-Lower Gallup Oil Pool, the Horseshoe-Gallup Oil Pool and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, and to the Ballard-Pictured Cliffs Pool, the South Blanco-Pictured Cliffs Pool and to the Blanco-Mesaverde Pool in San Juan and Rio Arriba Counties, New Mexico.

(3) That there is need to defer action on the proposed extension to the Angels Peak-Dakota Pool in San Juan County, New Mexico, pending the results of current pool studies.



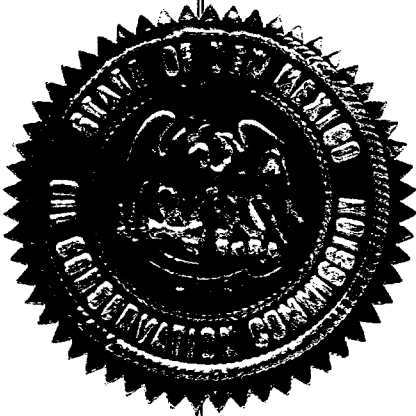
