(a) Create a new pool in Lea County, New Mexico classified as a gas pool for Seven Rivers production, designated as the Laguna Seven Rivers Gas Pool, and described as:

(b) Create a new pool in Lea County, New Mexico, classified as an oil pool for Pennsylvanian production, designated as the North Shoe Bar-Pennsylvanian Pool, and described as:

and such other, etc.

(c) Extend the Acme Pool boundary in Chaves County, New Mexico, to include therein:

Twp. 8 South, Range 27 East, Section 5: N/2

and such other, etc.

(d) Extend the Artesia Pool boundary in Eddy County, New Mexico, to include therein:

Twp. 18 South, Range 28 East, Section 23: SE/4

and such other, etc.

(e) Extend the Blinebry Gas Pool boundary in Lea, County, New Mexico, to include therein:

Two. 21 South, Range 37 East, Section 32: SE/4

and such other, etc.

(f) Extend thé Hare Pool boundary in Lea County, New Mexico, to include therein:

Twp. 22 South, Range 37 East, Section 4: S/2

and such other, etc.

(g) Extend the Hume-Queen Pool boundary in Lea County, New Mexico, to include therein:

Twp. 16 South, Range 34 East, Section 8: S/2 NW/4

and such other, etc.

(h) Extend the Jalmat Gas Pool boundary in Lea County, New Mexico, to include therein:

Twp. 22 South, Range 35 East, Section 3: SE/4 Section 10: SE/4

and such other, etc.

(i) Extend the Kemnitz-Wolfcamp Pool boundary in Lea County, New Mexico, to include therein:

Twp. 16 South, Range 34 East, Section 22: NW/4

and such other, etc.

(j) Extend the Milnesand-San Andres Pool boundary in Roosevelt County, New Mexico, to include therein:

Twp. 8 South, Range 34 East, Section 23: NE/4

and such other, etc.

(k) Extend the Tubb Gas Pool boundary in Lea County, New Mexico, to include therein:

Twp. 22 South, Range 38 East, Section 31: NE/4 & NE/4 SE/4

and such other, etc.
