ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 17, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 2/2 day of December, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Chimney Rock-Gallup Oil Pool was discovered by the R. L. Bayless Navajo Well No. 2, located in the NE/4 Section 5, Township 31 North, Range 17 West, NMPM. It was completed April 18, 1958. The top of the perforations is at 1,230 feet.
- (3) That there is need for certain extensions to the East Blanco-Pictured Cliffs Pool, the North Los Pinos-Dakota Pool and the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, the Bisti-Lower Gallup Oil Pool, the Horseshoe-Gallup Oil Pool and the Verde-Gallup Oil Pool in San Juan County, New Mexico and the Ballard-Pictured Cliffs Pool, the Blanco-Mesaverde Pool and the South Blanco-Pictured Cliffs Pool all in Rio Arriba and San Juan Counties, New Mexico.
