In the matter of the application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the creation of a new pool and the extension of existing pools in Rio Arriba and San Juan Counties, New Mexico.

(a) Create a new pool in San Juan County, New Mexico, classified as an oil pool for Gallup production, designated as the Chimney Rock-Gallup Oil Pool and described as:
