
DIAGRAMMATIC SKETCH OF DUAL COMPLETION

Dear Mr. Porter:

Under date of January 8 we forwarded to you in triplicate the application of the Atlantic Refining Company to commingle the production from separate reservoirs underlying the Atlantic State "Y" lease in the Justis Pool.

It has been called to our attention that we failed to include the Drinkard formation as a possible producing formation in Section 2 on page 2 of the application. We have rewritten page 2 and enclose original and two copies to be substituted for page 2 of the copies forwarded to you. The only other changes which are made for clarification purposes are the following:

1. In the 4th line of paragraph 3 we had added the word, "meter," after "orifice."

2. In the 5th line of paragraph 4 we have ended the sentence with the word, "measured," and deleted the words, "and kept separate."

These changes do not in any way change the intent or purpose of the application.
