ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 18, 1959, at Santa Fe, New Mexico, before the Cil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 23Rdday of February, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool, the South Blanco-Dakota Pool and the Escrito-Gallup Oil Pool all in Rio Arriba County, New Mexico, to the Aztec-Fruitland Pool, the Aztec-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Chimney Rock-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool and the Verde-Gallup Oil Pool in San Juan County, New Mexico and to the Blanco-Mesaverde Pool and the South Blanco-Pictured Cliffs Pool both in Rio Arriba and San Juan Counties, New Mexico.
