THE APPLICATION OF NEARBURG & INGRAM FOR THE APPROVAL OF ITS SQUARE LAKE DEEP UNIT AGREEMENT EMBRACING 4,317 ACRES, MORE OR LESS, LOCATED IN TOWNSHIPS 16 AND 17 SOUTH, RANGE 30 EAST, NMPM, EDDY COUNTY, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 25, 1959, at Santa Fe, New Mexico, before E. J. Fischer, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 2^{nd} day of March, 1959, the Commission, a quorum being present, having considered the application, the evidence adduced and the recommendations of the Examiner, E. J. Fischer, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the proposed unit plan will, in principle, tend to promote the conservation of oil and gas and the prevention of waste.

IT IS THEREFORE ORDERED:

1. That this order shall be known as the

SQUARE LAKE DEEP UNIT AGREEMENT ORDER

2. (a) That the project herein referred to shall be known as the Square Lake Deep Unit Agreement and shall hereinafter be referred to as the "Project." -2-Case No. 1608 Order No. R-1345

(b) That the Plan by which the project shall be operated shall be embraced in the form of a unit agreement for the development and operation of the Square Lake Deep Unit Area, referred to in the Petitioner's petition and filed with said petition, and such plan shall be known as the Square Lake Deep Unit Agreement Plan.

3. That the Square Lake Deep Unit Agreement Plan shall be, and hereby is, approved in principle as a proper conservation measure; provided, however, that notwithstanding any of the provisions contained in said unit agreement, this approval shall not be considered as waiving or relinquishing in any manner any right, duties or obligations which are now, or may hereafter, be vested in the New Mexico Oil Conservation Commission by law relative to the supervision and control of operations for exploration and development of any lands committed to said Square Lake Deep Unit Agreement, or relative to the production of oil and gas therefrom.

4. (a) That the unit area shall be:

TOWNSHIP 16 SOUTH, RANGE 30 EAST Section 26: All Section 33: All Section 34: All Section 35: All

TOWNSHIP 17 SOUTH, RANGE 30 EAST Section 3: W/2 Section 4: All Section 5: E/2 Section 8: NE/4 Section 9: N/2

containing 4,317 acres more or less.

(b) The unit area may be enlarged or contracted as provided in said Plan. Provided however, that administrative approval for expansion of the unit area must also be obtained from the Secretary-Director of the Oil Conservation Commission of New Mexico.

5. That the unit operator shall file with the Commission an executed original or executed counterpart of the Square Lake Deep Unit Agreement within 30 days after the effective date thereof.

6. That any party owning rights in the unitized substances who does not commit such rights to said unit agreement before the effective date thereof may thereafter become a party thereto by -3-Case No. 1608 Order No. R-1345

subscribing to such agreement or counterpart thereof, or by ratifying the same. The unit operator shall file with the Commission within 30 days an original of any such counterpart or ratification.

7. That this order shall become effective upon the approval of said unit agreement by the Director of the United States Geological Survey and shall terminate ipso facto upon the termination of said unit agreement. The last unit operator shall immediately notify the Commission in writing of such termination.
