## ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 14, 1959, at Roswell, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 22<sup>-Ch</sup> day of October, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico; to the Blanco-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool, and the West Kutz-Dakote Pool, all in San Juan County, New Mexico; and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.
