Dear Mr. Porter:

We request your approval of a change in location for our Horseshoe Ute No. 27. We had previously planned to drill this location 1980° from the South Line and 4430° from the East Line of Section 28, Township 31N, Range 16W.

During the Examiner Hearing held October 7, 1959, Case No. 1790, we requested that this location be changed to 660° from the South Line and 4430° from the East Line, Section 28, Township 31N, Range 16W. At that time we had not staked the location and, since that time, we have staked the location and on the 660° footage from the South Line it would take approximately \$10,000.00 to build a road to and make the location. We tried to move the location to the north and, in doing so, we had to go 90° from the South Line to even have a possible building site. In order to build the location 990° from the South Line it would take approximately \$5,000.00 to build a road to and make the location.

We staked a location 330° from the South Line and 4430° from the East Line of Section 28, Township 31N, Range 16W. It will be possible to make a location on this footage without going to a great expense.

Our Land Department has talked to the U.S.G.S. and they do not have any objection to moving the location to the 330° from the South Line and 4430° from the East Line of Section 28, Township 31N, Range 16W. They have also talked to the Atlantic Refining Company and they have no objection to moving the location. The Atlantic Refining Company will send a letter to the Conservation Commission stating that they will have no objection.

We request your approval as soon as possible so that we might be able to drill the well while we have a rig drilling in that immediate area.
