

Enclosed are applications to dual complete the above captioned well.

The attachments include the following:

1. A diagrammatic sketch of the dual completion, showing casing strings, size and settings, perforated intervals, tubing strings, size and setting depth, location and type of packer, and amount of cement used.
2. Plat showing the location of all wells on applicant's lease and all offset leases.
3. Electric log showing tops and bottoms of formations concerned. The enclosed electric log was unable to reach the total depth of 2500', but from drillers log, the bottom of the Lovington formation is 2480'.


