Applicants, in the above-styled cause, seek an order authorizing the institution of a water flood project in the Roberts Pool in Lea County, New Mexico, by the injection of water into the Grayburg formation through 11 wells located in Sections 2, 3, 10 and 11, Township 17 South, Range 32 East. Applicants further seek the establishment of an administrative procedure whereby capacity allowables may be assigned to wells in said project without notice and hearing.
