ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 18, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this developed day of November, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Rio Arriba County, New Mexico, for the production of gas from the Pictured Cliffs formation, said pool to bear the designation Pine Lake-Pictured Cliffs Pool. Said Pine Lake-Pictured Cliffs Pool was discovered by Socony Mobil Oil Co. Inc., Jicarilla "F" Well No. 1, located in the NW/4 NE/4, Section 22, Township 27 North, Range 3 West, NMPM. It was completed June 11, 1956. The top of the perforations is at 3880 feet.

(3) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool, and the South Blanco-Dakota Pool, all in Rio Arriba County, New Mexico, to the Blanco-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, and to the Blanco-Mesaverde Pool, in Rio Arriba and San Juan Counties, New Mexico. -2-Case No. 1810 Order No. R-1531


