TRANSCRIPT OF HEARING

MR. PORTER: We will take up next the nomenclature case for Northwest New Mexico.

MR. PAYNE: Case 1810: Northwestern New Mexico nomenclature case calling for an order creating and extending existing pools in Rio Arriba and San Juan Counties, New Mexico.

A. R. KENDRICK

called as a witness, having been first duly sworn on oath, testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

Q Will the witness please state his name and position?

A A. R. Kendrick.

Q Have you made a study concerning the necessity or desirability of creating and extending pools in Rio Arriba and San Juan Counties, New Mexico?

A I have.

Q What are your recommendations for the creation of a new gas pool for Pictured Cliffs production?

A I recommend that the new pool be created known as the Pine Lake-Pictured Cliffs Pool, based on thirty-three wells now producing in that area. Discovery well was drilled by Magnolia

Petroleum Company as the No. 1 Jicarilla "F" in Unit B of Unit 2, 27, North, 3 West, an absolute open flow of 845 MCF per day, completed June 11, 1956.

Q What do you recommend as the vertical limits?

A The Pictured Cliffs formation.

Q What do you recommend as the horizontal limits?

A As shown in paragraph (a) of Exhibit 1.

Q What are your recommendations concerning the Blanco-Pictured Cliffs Pool?

A That the Blanco-Pictured Cliffs Pool be extended as shown in paragraph (b) of Exhibit 1, on the basis of six wells producing from the Pictured Cliffs formation.

Q What are your recommendations concerning the extension of the Gavilan-Pictured Cliffs Pool?

A That the pool be extended as shown in paragraph (c) of Exhibit 1, on the basis of one well completed in that pool.

Q What are your recommendations concerning the extension of the Tapacito-Pictured Cliffs Pool?

A That the pool be extended as shown in paragraph (d) in Exhibit 1, on the basis of one well completed in that pool.

Q What are your recommendations concerning the extension of the Blanco-Mesaverde Pool?

A That the pool be extended as shown in paragraph (e) of Exhibit 1, on the basis of two wells completed in that pool.

Q What are your recommendations concerning the extension



of the Bisti-Lower Gallup Oil Pool?

A That the pool be extended as shown in paragraph (f) of Exhibit 1 on the basis of one well producing from that pool.

Q What are your recommendations concerning the extension of the Horseshoe-Gallup Oil Pool?

A That the pool be extended as shown in paragraph (g) of Exhibit 1 on the basis of three wells producing from that pool.

Q What are your recommendations concerning the extension of the Verde-Gallup Oil Pool?

A That the pool be extended as shown in paragraph (h) of Exhibit 1, on the basis of one well producing from that pool.

Q What are your recommendations concerning the extension of the South Blanco-Dakota Pool?

A That the pool be extended as shown in paragraph (i) of Exhibit 1 on the basis of seven wells producing from that pool.

Q Have you prepared an exhibit substantiating your recommendations?

A I have.

Q How is that designated?

A New Mexico Oil Conservation Commission Exhibit No. 1, Case 1810.

MR. PAYNE: We move the introduction of Exhibit 1 in 1810.

MR. PORTER: Without objection the exhibit will be admitted. Any questions?

CROSS EXAMINATION

BY MR. UTZ:

Q Is the new Pine Lake-Pictured Cliffs Pool recommended close to any other Pictured Cliffs Pool in the Northwest New Mexico at the present time?

A Did you say is it close to any other pool?

Q Yes.

A It is more or less centrally located between three other pools.

Q Which three pools?

A Gavilan-Pictured Cliffs, Chosama, and Tapacito.

Q It wouldn't be a part of Tapacito then, you don't think?

A I don't think so.

MR. PORTER: Mr. Kendrick, how many wells is this recommendation based on?

A Thirty-three.

MR. PORTER: Thirty-three wells?

A Yes, sir.

MR. PORTER: They're located kind of equi-distant from three other Pictured Cliffs Pools?

A Well, they are a minimum of two miles from the other pools, or something in that order.

MR. PORTER: I see. They would be at least two miles from either of them, then?

A Yes, sir.

MR. PORTER: You feel it would be wise to go ahead and create the pool and later, if subsequent development should indicate we should do so, that it be included as part of one of the other pools?

A Yes, sir, that it could be joined with one or more of the other pools.

MR. PORTER: Excuse me, Mr. Utz, were you through?

MR. UTZ: Yes.

MR. PORTER: Does anyone else have a question? We'll take the case under advisement. The hearing is adjourned.
