### GEOLOGICAL NEMORANDUM Concerning PROPOSED SOUTHWEST MESCALERO UNIT AREA Lea County, New Mexico

The proposed Southwest Mescalero Unit Area is located in Sections 32 and 33, Township 10 South, Range 32 Bast, N.M.P.M., Lea County, New Mexico.

The attached reflection seimmegraph map depicts the attitude of sedimentary beds at the Devonian horizon. This work, based on a constant velocity, has delineated a structural closure approximately one mile long and three-fourths of a mile wide trending in a Morthwest-Southeast direction.

Production has been obtained approximately one and one-half miles to the northeast in the Mescalero Field from the Virgil series of the Pennsylvanian (approximately 8300 to 8450 feet in depth) and the Devonian formation (approximately 9850 feet in depth).

Production has been obtained approximately four and one-half miles to the south in the Moore Field from the Welfsamp (approximately \$150 feet in depth), the Atoka and Virgil series of the Pennsylvanian (approximately 9650 to 9800 feet in depth) and the Deventian formation formation (approximately 10,100 feet to 10,600 feet in depth).

It is recommended that the Southwest Mescalero Unit include all formations.

In order to test the potentially productive horizons which have indicated good porosity developments in other deep tests in this province, a hole should be drilled to a depth sufficient to penetrate

the Devomian. The probable sequence of sediments and anticipated depths are contained in the following tabulation:

Porosity somes are expected in the Wolfcamp, Pennsylvanian and Devonian.

The most favorable location for the above test is 1980 feet from the north and west lines of Section 33, Township 10 South, Range 32 East.

A depth of 11,000 feet should be adequate to test the Devonian formation.

It is requested that the information contained herein and the seismic map attached be classified confidential.
