

Gentlemen:

The Pebble Queen Unit, located in Chaves County, New Mexico, was effective April 1, 1960. The Unit, as now constituted, contains 24 developed 40 acre proration units. The unitization formula was:

10% (tract wells) + 25% (tract millidarcy feet) + 65% (tract remaining recoverable oil) (unit wells) + 25% (unit millidarcy feet) + 65% (unit remaining recoverable oil)

It has now been proposed and approved by approximately 97.59% of the working interest owners that the Unit be enlarged to include two additional developed 40 acre tracts which have been recently completed. 97.59% of the present working interest owners and all of the working interest owners in the new tracts have agreed to expand the Unit by the addition of these two tracts on the following basis:

 $90\% \begin{bmatrix} 10\% & (\frac{\text{tract wells}}{(\text{unit wells})} + 25\% & (\frac{\text{tract millidarcy feet}}{(\text{unit millidarcy feet})} + 65\% & (\frac{\text{tract remaining recoverable oil}}{(\text{unit remaining recoverable oil})} \end{bmatrix}$ 

or, in effect, it has been agreed that 90% of the original participation formula would serve equity for all concerned. It was felt that the 10% participation penalty would compensate the present working interest and royalty owners for the loss in current production they will suffer when the Unit is expanded.

The attachment to this letter outlines the various parameters used to arrive at the formula.
