ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on
April 13, 1960, at Hobbs, New Mexico, before the Oil Conserva-
tion Commission of New Mexico, hereinafter referred to as the
"Commission."

NOW, on this 25th day of April, 1960, the Commission, a
quorum being present, having considered the evidence adduced at
said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required
by law, the Commission has jurisdiction of this cause and the
subject matter thereof.
- (2) That the date originally scheduled for the Regular
Commission Hearing in June, 1960 (15th) conflicts with the Semi-
Annual Meeting of the Interstate Oil Compact Commission.
- (3) That accordingly the date of the Regular Commission
Hearing in June, 1960, should be changed from the 15th day of
the month to the 10th day of the month.

IT IS THEREFORE ORDERED:

That the date of the Regular Commission Hearing in June,
1960, be and the same is hereby changed from the 15th day of
the month to the 10th day of the month.

MR. PORTER: Take up next Case 1936.

MR. PAYNE: Case 1936. In the matter of the hearing called
by the Oil Conservation Commission on its own motion to consider
changing the date of the Regular Commission Hearing in June, 1960,
from the 15th to the 10th.

DANIEL S. NUTTER,

called as a witness, having been duly sworn, testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

Q Will the witness please state his name and position?

A Dan Nutter. I am Chief Engineer for the Oil Conservation

Commission.

Q Mr. Nutter, are you familiar with the circumstances surrounding the calling of Case 1936?

A Yes, sir, I am.

Q For what reason does the Commission desire to change the hearing date in June from the 15th to the 10th?

A The Interstate Oil Compact Commission has scheduled its semi-annual meeting for dates in June, which would conflict with the date of the hearing as previously set by the Commission. Several members of the Commission, as well as the Commission staff, are members of standing committees of the Compact, and it's felt that the hearing date should be changed in order to make it possible for the members of these committees to attend the compact meeting.

Q Mr. Nutter, would you urge that all purchasers submit their nominations early?

A Yes, sir. It will be necessary for the purchasers to submit their nominations earlier than usual for the month of June. We would appreciate having them five days before the date of the hearing, if possible.

MR. PAYNE: That concludes the testimony of this witness.

MR. PORTER: Any questions of the witness concerning the changes of these dates? The witness may be excused.

(Witness excused)

MR. PORTER: The Commission has ruled on that or will rule on that case. The dates will be changed. Keep that in mind,
