## ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 13, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 15th day of July, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Fruitland Pool, the Angels Peak-Dakota Pool, the Blanco-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico; and to the Devils Fork-Gallup Pool, the Escrito-Gallup Oil Pool, the South Blanco-Dakota Pool, and the South Blanco-Pictured Cliffs Pool, all in Rio Arriba County, New Mexico; and to the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Fruitland Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
