Q Have you made a study concerning the necessity or desira-
bility for extending certain existing pools in San Juan and Rio
Arriba Counties in New Mexico?

A I have, and part of Sandoval County.

A That it be extended as shown in Paragraph (a) of Exhibit 1 on the basis of one well completed in that pool.

Q And what are your recommendations concerning the Ballard?

A That it be extended as shown in Paragraph (b) of Exhibit 1 on the basis of two wells completed.

Q What are your recommendations concerning the extension of the Pine Lake-Pictured Cliffs Pool?

A That it be extended as shown in Exhibit 1, Paragraph (c), on the basis of one well completed in the area.

Q What are your recommendations concerning the South Blanco-Pictured Cliffs Pool?

A That the pool be extended as shown in Paragraph (d) on Exhibit 1, on the basis of two wells completed.

Q What are your recommendations concerning extension of the Tapicito-Pictured Cliffs Pool?

A That the pool be extended as shown in Paragraph (e) of Exhibit 1, on the basis of one well completed.

Q What are your recommendations concerning the Escrito-Gallup Oil Pool?

A That the pool be extended as shown in Paragraph (f) of Exhibit 1 on the basis of two completions.

Q What are your recommendations concerning the extension of the Horseshoe-Gallup Oil Pool?

A That it be extended as shown in Paragraph (g) of Exhibit
