duly sworn, testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

Q Would you state your name?

A A. R. Kendrick.

Q By whom are you employed?

A The Oil Conservation Commission of New Mexico.

Q In what capacity?

A As Engineer in District 3.

Q Mr. Kendrick, have you made a study concerning the necessity or desirability for extending certain existing pools in San Juan and Rio Arriba **Counties, New Mexico?**

A I have.

Q What are your recommendations regarding the Aztec-Pictured Cliffs Pool?

A That it be extended as shown in paragraph A, of Exhibit 1, on the basis of two wells producing therein.

Q What are your recommendations concerning the extension of the Blanco-Pictured Cliffs Pool?

A That the Blanco-Pictured Cliffs Pool be extended as shown in paragraph B, of Exhibit 1, on the basis of one well completed in that pool.

Q What are your recommendations concerning the extension of the South Blanco-Pictured Cliffs Pool?

A That the South Blanco-Pictured Cliffs boundary be extended as shown in paragraph C, of Exhibit 1, on the basis of one completion in that pool.

Q What are your recommendations concerning the extension of the Tapacito-Pictured Cliffs Pool?

A That the Tapacito-Pictured Cliffs Pool boundary be



extended as shown in paragraph D, and based on one completion in this pool.

Q What are your recommendations concerning the extension of the West Kutz-Pictured Cliffs Pool?

A That the boundary be extended as shown in paragraph E, of Exhibit 1, on the basis of two completions in that pool.

Q What are your recommendations concerning the extension of the Blanco-Mesa Verde Pool?

A That the pool boundary be extended as shown in paragraph F, of Exhibit 1, because of the non-standard unit created by Order R-1714, which included the acreage.

Q What are your recommendations concerning the extension of the Otero-Gallup Oil Pool?

A That the Otero-Gallup Oil Pool boundary be extended as shown in paragraph G, Exhibit 1, on the basis of two completions in this pool.

Q What are your recommendations concerning the extension of the Verde-Gallup Oil Pool?

A That the Verde-Gallup Oil Pool boundary be extended as shown in paragraph H, of Exhibit 1, on the basis of one completion in that pool.

Q Have you prepared Exhibit No. 1, to substantiate your recommendations, Mr. Kendrick?

A I have.

Q Do you have anything further?



A No.

MR. PAYNE: I move for the introduction of Exhibit 1, in Case 2098.

MR. PORTER: Without objection, the Exhibit will be admitted. Does anyone have any questions?




REPORTER'S CERTIFICATE
