#### BEFORE THE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO

IN THE MATTER OF THE HEARING CALLED BY THE OIL COMSERVATION COMMISSION OF NEW MEXICO FOR THE PURPOSE OF COMSIDERING:

APPLICATION OF THE OIL CONSERVATION COMMISSION OF ITS OWN MOTION, AT THE REQUEST OF HARL G. COLFON, TO CONSIDER GRANTING PERMISSION TO DRILL AN EXPLORATORY TEST WELL IN THE POTASH-OIL AREA, LRA COUNTY, MEW MEXICO.

#### ORDER OF THE COMMISSION

### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 15, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 22nd day of Pebruary, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises.

#### FIMDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Barl G. Colton, seeks permission to drill an emploratory test well in the ME/4 SE/4 of Section 29, Township 20 South, Range 34 East, MMPM, Les County, New Mexico, which acreage is included within the potash-oil area as delineated by Commission Order No. R-111-A and subsequent amendments thereto.
- (3) That the applicant's proposed casing program is to be in accordance with the requirements of said Order No. R-111-A.
- (4) That the Potash Company of America objected to the proposed location, arbitration proved unsuccessful, and, as provided by said Order No. R-lil-A, the matter was then heard by the Oil Comservation Commission.
- (5) That the proposed oil well location is approximately twelve (12) miles from the nearest active potash operations, and,

further, it is speculative and conjectural as to when, if ever, the area in which the location is proposed will be mined for potash, and, inasmuch as there are no present plans for such mining, the cil and gas lessee should be allowed to drill the subject well and produce it to depletion, at which time, as reflected by the evidence, said well could be plugged in such a manner as to protest the potash reserves.

- (6) That in view of the circumstances set forth in the preceding finding, denial of the right to drill the subject exploratory test well would result in an impairment of the oil and gas lesses's correlative rights, particularly since a number of oil wells have long since been drilled in the general area.
- (7) That the applicant should be permitted to drill the subject well.

#### IT IS THEREPORE ORDERED:

That the applicant, Earl G. Colton, is hereby permitted to drill am emploratory test well in the ME/4 SE/4 of Section 29, Township 20 South, Range 34 East, HMPM, Lea County, New Maxico, at a point 1980 feet from the South line and 330 feet from the East line of said Section 29.

PROVIDED HOWEVER, That the subject well shall be completed and plugged in full compliance with the requirements set forth in Commission Order No. R-111-A.
