Gentlemen:

We have noted that hearing has been set for March 22 on request of Mr. Len Mayer for approval of an unorthodox location for an Atocha Penn gas well 1850' FSL and 990' DWL of Section 28, Township 18 South, Range 26 East, Elddy County, New Mexico. Although we have received no additional information concerning Mr. Mayer's acreage since our letter of February 24, 1961, we anticipate that at the hearing he will present such pertinent information as he may have.

As we do not plan to have a representative present at the hearing, we considered it appropriate to advise you and Mr. Mayer of our position in this matter.

If the evidence at the hearing establishes to the satisfaction of the Commission that the proposed unorthodox location is justified and that correlative rights of interested parties will not be adversely affected, we would have no objection to either the unorthodox location or the dedication of the entire S/2 of Section 28 to the well without restriction of the allowable below the allowable of wells on other standard units in the Pool.

Dear Sir:

We have reviewed your letter of February 16 in which you state that you have requested approval for a "non-standard" gas unit covering the S/2 of Section 28. However, as we construe your letter, you are seeking approval of an unorthodox well location as an exception to Rule 3 of the Pool Rules in order to drill your proposed well in the SW/4 of Section 28 instead of in the SE/4. Under the Pool Rules for the Atoka Penn Gas Pool, the Secretary-Director is not authorized to approve an unorthodox well location except where necessary because of topographical conditions, or in order to permit the recompletion of a previously existing well. Although you did not furnish us with a copy of your Application, we understand that neither of those conditions exists.

We object to the approval of your proposed unorthodox location without a hearing. However, if we are furnished with sufficient information to justify your proposal to drill at the unorthodox location, we would have no objection to your doing so, provided the allowable to be assigned to the well in the unorthodox location is restricted below the allowable for a standard unit to an amount which would protect the correlative rights

of The Ohio and its royalty owners and would insure that only acreage which is productive of gas from the Atoka Penn Formation would be included in fixing the allowable for the well. Our present thought is that the proposed well would not be entitled to an allowable in excess of one half of the allowable assigned to a standard unit in the pool.

Please advise whether you concur in our view that a hearing will be necessary.
