IN THE MATTER OF THE HEARING CALLED BY THE OIL CONSERVATION COMMISSION OF NEW MEXICO FOR THE PURPOSE OF CONSIDERING:

APPLICATION OF TEXACO INC., FOR AN OIL-OIL-OIL TRIPLE COMPLETION (CONVENTIONAL) IN THE EUMONT GAS POOL, THE PENROSE-SKELLY POOL, AND THE DRINKARD POOL, LEA COUNTY, NEW MEXICO.

### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 28, 1961, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 7th day of July, 1961, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Texaco Inc., is the owner and operator of the C. P. Falby (a) Well No. 4, located in Unit E, Section 8, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That the applicant proposes to complete the abovedescribed C. P. Falby (a) Well No. 4 as a triple completion (conventional) in such a manner as to permit the production of oil from the Eumont Gas Pool, the production of oil from the Penrose-Skelly Pool, and the production of oil from the Drinkard Pool, utilizing three parallel strings of 2 3/8-inch tubing.

(4) That the mechanics of the proposed triple completion are feasible and in accord with good conservation practices.

(5) That approval of the subject application will neither cause waste nor impair correlative rights.

# IT IS THEREFORE ORDERED:

That the applicant, Texaco Inc., is hereby authorized to complete its C. P. Falby (a) Well No. 4, located in Unit E, Section 8, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, as a triple completion (conventional) in such a manner as to permit the production of oil from the Eumont Gas Pool, the production of oil from the Penrose-Skelly Pool, and the production of oil from the Drinkard Pool through parallel strings of 2 3/8-inch tubing with permanent type packers to be set at depths of 3650 feet and 3775 feet.

PROVIDED HOWEVER, That the applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A.

<u>PROVIDED FURTHER</u>, That the applicant shall take packerleakage tests upon completion and annually thereafter during the Annual Gas-Oil Ratio Test Period for the Drinkard Pool, or at such other times as the Secretary-Director of the Commission may prescribe.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
