A Yes, sir. I am.

Q And in that regard, have you prepared an Exhibit in this Case?

A Yes, sir. I have.

Q Referring to this Exhibit, what is your recommendation as to the Baish-Wolfcamp project?

A It is recommended that the new oil pool of the Baish-Wolfcamp Pool have certain vertical limits capable of producing. The Wolfcamp, Paragraph A, Exhibit 1 lists Discovery Well as Continental Oil Company-Baish 1-B No. 14 located in Unit C of Section 22, Township 17 South, Range 32 East and completed on May 11, 1962. Top of perforations 9,808 feet.

Q And what is your recommendation referring to paragraph B concerning the creation of a new oil pool for San Andres production?

A It is recommended that the new oil pool known as the Mescalero-San Andres have certain vertical limits, San Andres form and important limits and as shows in the Paragraph B, Exhibit 1, Discovery Well is Cities Service Production Company, -State AD No. 2 in Unit I of Section 22, Township 10 South, Range 32 East, completed May 11, 1962. Top of perforations 4200 feet.

Q Referring to paragraph C, the creation of a new oil pool for Tonto-Wolfcamp production?

It is recommended the Tonto-Wolfcamp pool have certain

Q Referring to Paragraph D, what is your recommendation concerning deletion in the Eumont Gas Pool?
