ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 18, 1962, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 20th day of July, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool, Tapacito-Pictured Cliffs Pool and the Puerto Chiquito-Gallup Oil Pool, all in Rio Arriba County, New Mexico, the Aztec-Pictured Cliffs Pool and the Flora Vista-Mesaverde Pool in San Juan County, New Mexico, and the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

**TOWNSHIP 31 NORTH, RANGE 11 WEST, NMPM
SECTION 30: NE/4**
