## ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 10, 1962, at Santa Fe, New Mexico, before Danial S. Matter Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 22nd day of October, 1962, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Odessa Natural Gasoline Company, seeks the establishment of a 320-acre non-standard gas proration unit in the Justis Gas Pool comprising the SE/4 of Section 23 and the NE/4 of Section 26, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That the applicant proposes to dedicate the abovedescribed unit to its Carlson "A" Well No. 1, located in Unit P of Section 23, Township 25 South, Range 37 East, MMPM, Lea County, New Mexico.

(4) That the proposed 320-acre non-standard gas promation unit may be reasonably presumed to be productive of gas from the Justis Gas Pool.

(5) That approval of the subject application will neither cause waste nor impair correlative rights.

## IT IS THEREFORE ORDERED:

(1) That a 320-acre non-standard gas proration unit in the Justis Gas Pool comprising the SE/4 of Section 23 and the NE/4 of Section 26, Township 25 South, Range 37 Mast, MMPM, Lea County, New Mexico, is hereby established. Said unit is to be dedicated to the Carlson "A" Well No. 1, located in Unit P of Section 23, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico.

(2) That the acreage factor for allowable purposes assigned to the above-described 320-acre non-standard gas provation unit shall bear the same ratio to a standard acreage factor as the acreage in said unit bears to the acreage in a standard gas provation unit in the Justis Gas Pool.

(3) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
