# BEFORE THE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO

### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 10, 1962, at Santa Fe, New Mexico, before Daniel S. Nutter Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 22nd day of October, 1962, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Pan American Petroleum Corporation, is the owner and operator of the South Mattix Unit Well No. 14, located in Unit K of Section 15, Township 24 South, Range 37 East, MMPM, Lea County, New Mexico.
- (3) That the applicant seeks permission to complete said South Mattix Well No. 14 as a triple completion (conventional) in such a manner as to produce gas from the Fowler-Paddock Gas Pool and an undesignated Tubb gas pool through parallel strings of 2.0-inch OD tubing, and to produce oil from the Fowler-Blinebry Oil Pool through 2 3/8-inch OD tubing.
- (4) That the mechanics of the proposed triple completion are feasible and in accord with good conservation practices.
- (5) That approval of the subject application will neither cause waste nor impair correlative rights.

#### IT IS THEREFORE ORDERED:

(1) That the applicant, Pan American Petroleum Corporation, is hereby authorized to complete its South Mattix Unit Well No. 14, located in Unit K of Section 15, Township 24 South, Range 37 East, NMPM, Lea County, New Mexico, as a triple completion (conventional) in such a manner as to produce gas from the Fowler-Paddock Gas Pool and an undesignated Tubb gas pool through parallel strings of 2.0-inch OD tubing, and to produce oil from the Fowler-Blinebry Oil Pool through 2 3/8-inch OD tubing.

PROVIDED HOWEVER, That the applicant shall complete, operate and produce said well in accordance with the provisions of Rule 112-A of the Commission Rules and Regulations.

PROVIDED FURTHER, That the operator shall take packer-leakage tests upon completion and annually thereafter during the Shut-In Pressure Test Period for the Tubb Gas Pool, and at such other times as the Secretary-Director of the Commission may prescribe.

(2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
