TRANSCRIPT OF PROCEEDINGS

MR. PORTER: We will now take up Case 2730.

MR. DURETTE: Case 2730. Southeastern New Mexico nomenclature case calling for an order creating new pools and extending certain existing pools in Eddy, Lea and Roosevelt Counties, New Mexico.

DANIEL S. NUTTER, a Witness, called by the Applicant, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. DURETTE:

Q Will you please state your name, and position, for the record?

A Dan Nutter, Chief Engineer for the Oil Conservation

Commission.

Q Mr. Nutter, are you prepared to recommend to the Commission today, that it enter an order creating new pools, and extend pools, in Eddy, Lea, and Roosevelt Counties, New Mexico?

A Yes, sir.

Q Have you prepared your recommendations in the form of an exhibit?

A Yes, sir.

Q Would you please proceed through this exhibit, Mr. Nutter, and state any changes that appear in that exhibit, that differentiate it from the docket in this case?

A I would recommend that a new oil pool, the North Baish-Wolfcamp Pool, be created comprising the SW/4 of Section 10, Township 17 South, Range 32 East. The pool was discovered by Pan American's North Maljamar Unit No. 1 in the SW/4, Unit "N" of Section 10. This well was completed on November 17, 1962; the top of the perforation is 10,834 feet.

I further recommend that the Vacuum-Devonian Pool be created in the SE/4 of Section 26, Township 17 South, Range 34 East. This pool was discovered by Socony Mobil's State Bridges Number 95, in Unit "P" of Section 26; completed in the Devonian, September 20, 1962; top of the perforation is 12,070 feet.

I would recommend that the case calling for the creation of the Vacuum-Paddock Pool in the NE/4 of Section 26, and the NW/4 of Section 25, Township 17 South, Range 34 East, be dismissed pending

further study. That was Paragraph "c" of this case.

I recommend that Paragraphs "d", "e", "f", "g", "h", "i", "j", be extended as shown on the exhibit, which is identical to the manner in which they were proposed to be extended on the docket.

In Paragraph "k", I would recommend that it be extended as shown on the exhibit, which is the same as on the docket, and also includes the SE/4 of Section 24, Township 8 South, Range 34 East.

In Paragraph "l", I would recommend it be created as shown on the exhibit, which includes the acreage shown on the docket, as well as Lots 3 and 6 and 4 and 5 of Section 4, Township 21 South, Range 36 East.

MR. KAPTEINA: You stated "created".

A Extended. In Paragraph "m", I recommend the East Red Oake-Queen Pool be extended as shown on the docket and on the exhibit; the additional acreage on the exhibit that is not shown on the docket, is the SE/4 of Section 36, Township 16 South, Range 28 East, and the NW/4 SW/4 of Section 31, Township 16 South, Range 29 East.

I would recommend that Paragraph's "n", "o", and "p" be adopted as shown on the docket, as well as the exhibit.

Q (By Mr. Durette) Thank you, Mr. Nutter. In the interest of clarification, did you recommend that Paragraph "c", as shown on the docket, concerning the Vacuum-Paddock Pool, be dismissed and continued possibly or considered possibly at a later date?

A Yes, sir.
