

CASE 3293: Southeastern New Mexico nomenclature case calling for an order for the creation, abolishment and extension of certain pools in Lea, Roosevelt and Eddy Counties, New Mexico:

a) CREATE A new oil pool for Wolfcamp production designated as the Burtner-Wolfcamp Pool. The discovery well is Standard Oil Company of Texas, State 22 No. 1 located in Unit H of Section 22, Township 15 South, Range 33 East, NMPM. Said pool described as:
