Gentlemen:

Your application of September 28, 1979, filed with the Production and Unit Agreement Supervisor, Roswell, New Mexico, requests preliminary approval of a proposed expansion of the La Plata Mancos unit area, San Juan County, New Mexico.

The La Plata Mancos unit agreement, No. 14-08-0001-11569, was approved effective June 1, 1969. The unit area presently contains 2,993.3 acres, more or less, following the 1977 elimination of some of the acreage within the initial unit area. Your proposed expansion will add 309.42 acres, more or less, to the unit area and would be included in the participating area. The expansion consists of 189.42 acres (61.2%) of Federal land, 80.00 acres (25.9%) of fee land, and 40.00 acres (12.9%) of state land. Upon approval of such expansion, the La Plata Mancos unit area will be increased to 3,302.72 acres, more or less.

The proposed expansion and inclusion in the participating area is regarded as acceptable on the basis of being necessary for unit operations. Accordingly, no objection will be offered to the proposed expansion of the La Plata Mancos unit area if it is accomplished in accordance with the applicable provisions of Section 2 of the unit agreement within one year of the date of this preliminary approval. All terms and conditions of the unit agreement will apply to the expanded portion of the unitized area in the same manner as to the original unit area.

A minimum of five copies of the application for final approval, accompanied by the appropriate joinders, should be filed with our Albuquerque, New Mexico office.

The format of the original exhibits attached to the unit agreement should be followed closely in the preparation of revised Exhibits A and B. The existing tracts should not be renumbered.

Dear Sir:

In response to your recent requests we are sending you copy of our application dated September 28, 1979, addressed to the U.S.G.S., to your office and to the Oil Conservation Division regarding expansion of the La Plata Mancos Unit. We understand that you do not have in your files this application, but you do have Mr. Smith's letter of October 4, 1979 requesting information following receipt of the proposal. To complete your files we are sending you also our response to Mr. Smith's letter.

I believe you have copy of letter from the U.S.G.S. approving the plan and referring to it as a "preliminary application" amd allowing a year to present the final application. It was our understanding when we made the application last October that we had done all that was required under the terms of the Unit Agreement to qualify for final approval and that once approved by the U.S.G.S. and the State Land Office, the expansion would be effective - as called for in the Unit Agreement - on the first of the month following the date of the application, which would be November 1, 1979. For this reason, and in order to save paperwork (retroactive adjustments of reporting of production, income and taxes) we have reported the G-32 well as being part of the unit production since November 1, 1979. We have not yet pursued this issue with the U.S.G.S., but it is our intention to do so. If the U.S.G.S. concurs, then when we have received your approval and the U.S.G.S. approval, the effective date will be November 1, 1979 and it will not be necessary to file amended production reports.

If, however, the effective date will be different from November 1, 1979 - or if either the U.S.G.S. or the State Land Office should not approve the application then we will, of course, be required to file amended reports.


