A Yes, I have.

Q Have you prepared an exhibit substantiating your recommendations?

A Yes, I have marked the exhibit in Case 2245.

Q Referring to that exhibit, what recommendations do you have concerning the extension of the Gavilan Pictured Cliffs pool?

A I recommend this pool be extended as shown on paragraph A, Exhibit 1 on the basis of one well completed in this pool.

Q What recommendation do you have concerning the extension of the Angels Peak Gallup Oil pool?

A I recommend that it be extended in paragraph B, Exhibit 1 on the basis of one well completed in the pool.

Q What recommendation do you have concerning the extension of the Cha Cha-Gallup Oil pool?

A It is recommended that it be extended as shown in paragraph C, Exhibit 1 on the basis of one well completed in this pool.

Q What recommendation do you have concerning the extension of the Totah-Gallup Oil pool?

A It is recommended that it be extended as shown in paragraph D, Exhibit 1 on the basis of three wells completed in this pool.
