- ALLOWABLE:**
- (1) Consideration of the oil allowable for March, 1963.
  - (2) Consideration of the allowable production of gas for March, 1963, from ten prorated pools in Lea and Eddy Counties, New Mexico, also consideration of the allowable production of gas from nine prorated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, for March, 1963.

CASE 2694: (De Novo)  
Application of Southern Union Production Company for an amendment to the Northwest New Mexico Gas Proration Rules and Regulations. Applicant, in the above-styled cause, seeks an amendment to Order No. R-1670 as amended by Order No. R-2086, Rules and Regulations for prorated gas pools, San Juan, Rio Arriba, McKinley and Sandoval Counties, New Mexico, to permit wells ordered shut-in for extended periods to make up accumulated overproduction to produce not more than 500 MCF each month during such shut-in. Upon application of Southern Union Production Company, this case will be heard de novo under the provisions of Rule 1220.

CASE 2504: (Rehearing - Continued from December 19, 1962)  
Application of Consolidated Oil & Gas Inc., for an amendment of Order No. R-1670-C, changing the allocation formula for the Basin-Dakota Gas Pool, San Juan, Rio Arriba and Sandoval Counties, New Mexico. Applicant seeks an amendment of Order No. R-1670-C to establish an allocation formula based 60% on acreage and 40% on acreage times deliverability. The Commission will hear opening statements and under the provisions of Rule 1214, and Rule 1215, may refer the presentation of evidence concerning recoverable reserves in the Basin-Dakota Gas Pool to Daniel S. Nutter, duly appointed examiner, or A. L. Porter, Jr., alternate examiner. The Commission would then hear all closing arguments.

CASE 2753: Southeastern New Mexico nomenclature case calling for an order renaming, creating, abolishing and extending certain pools in Lea, Eddy, and Chaves Counties, New Mexico.

(a) Rename the Vacuum-Abo Pool, classified as an oil pool for Abo production, to the Vacuum-Abo Reef Pool with the vertical limits of said pool changed from the entire Abo formation to the Abo Reef formation and the horizontal limits the same. This change is necessary to correct for geologic nomenclature.

(b) Create a new oil pool for Bone Spring production, designated as the Greenwood-Bone Spring Pool, and described as:

TOWNSHIP 19 SOUTH, RANGE 31 EAST, NMPM  
Section 12: NE/4

(c) Create a new oil pool for Strawn production, designated as the Greenwood-Strawn Pool, and described as:

TOWNSHIP 19 SOUTH, RANGE 31 EAST, NMPM  
Section 12: NE/4

(d) Create a new oil pool for Glorieta production, designated as the Vacuum-Glorieta Pool, comprising the SE/4 of Section 26, Township 17 South, Range 34 East, with the vertical limits thereof described as being from the top of the Glorieta as depicted at 5840 feet on the log of Socony Mobil Oil Company's State Bridges Well No. 95, located in Unit P of said Section 26, to a point 275 feet above the Blinebry marker found at 6510 feet on said log.

(e) Create a new oil pool for Blinebry production, designated as the Vacuum-Blinebry Pool, comprising the SE/4 of Section 26, Township 17 South, Range 34 East, with the vertical limits thereof described as being from 275 feet above the Blinebry marker at 6510 feet on the above described log to the top of the Tubb formation at 7238 feet on said log.

(f) Create a new oil pool for Abo production, designated as the North Vacuum-Abo Pool, with vertical limits defined as the Abo formation, and described as:

We respectfully request that the Commission deny the application of Consolidated Oil & Gas, Inc. and leave the allocation formula for the Basin Dakota Pool as it is.

Gentlemen:

Continental Oil Company wishes to be on record supporting the application of Consolidated Oil and Gas Company in Case 2504 to change the gas allocation formula to 60% acreage and 40% acreage times deliverability. It is our contention that the emphasis on deliverability in the present formula results in economic waste. An operator often spends many thousands of dollars sandfracing a well to increase the deliverability in order to obtain a bigger allowable. This increase in deliverability is not needed to meet the current demands since the allowable is much less than the deliverability. Thus, in order to be competitive, an operator must waste many thousands of dollars developing deliverability of gas that cannot be sold. The oil industry today must take every opportunity to reduce their costs and the elimination of the waste in developing large gas deliverabilities is one way the industry can reduce its overall costs. For this reason, Continental supports the reduction in deliverability as a factor for computing gas allocations.

We have been advised by the Oil Conservation Commission of the State of New Mexico that you have filed several motions to quash or dismiss, in whole or in part, the subpoena ~~duces tecum~~ served upon David H. Rainey in case number 2504 before the Commission.

You are no doubt aware that Consolidated Oil & Gas, Inc., initiated the subpoenas and as such is willing to cooperate with El Paso Natural Gas Company in any reasonable way so long as the desired information is made available at the rehearing of case number 2504 as expert testimony.

As to the subpoena itself, it is obvious that the production of the eight data sheets described in item 1 is not an onerous problem and this should cause you no trouble. As to item 2, if Mr. Rainey would like to prepare a simple modification of the eight data sheets so that the identification of each well and its location is clearly shown thereon, then there will be no need to bring underlying books, records and papers. This assumes, of course, that Mr. Rainey would be willing to state that these are the proper identifications of the eight wells, etc.

As to item 3 on the subpoena, again we are interested only in competently established results and if Mr. Rainey would be willing to create a new set of data sheets covering wells other than the 457 wells covered by item 1 and which showed the identification and location of the wells and the recoverable well reserves attributable to them, this should certainly save interference with your company's books, records and papers. Such a tabulation should, of course, include

the same data for tracts or parcels upon which no well has been drilled or which is not yet producing insofar as such information has been developed by or in the possession of El Paso Natural Gas Company. In using such a shortcut, it is expected that Mr. Rainey would testify that the original work was done according to approved engineering methods and generally support the data as expert opinion subject, of course, to any qualifications which he would feel it necessary to make.

If in the spirit of cooperation the Company would be willing to furnish to us in advance of the hearing copies of such data sheets and tabulations, it is certain that the time which will be consumed at the hearing would be materially shortened.




