THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m., on November 14, 1962, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>l6th</u> day of November, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the proposed creation of a new pool in Section 16, Township 10 South, Range 27 East, Chaves County, New Mexico, for the production of oil from the San Andres formation should be dismissed due to improper legal notice.
- (3) That there is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Abo formation, said pool to bear the designation of Goodwin-Abo Pool. Said Goodwin-Abo Pool was discovered by Continental Oil Company, State GG 30 No. 1, located in the SW/4, Unit K, of Section 30, Township 18 South, Range 37 East, NMPM. It was completed August 21, 1962. The top of perforations is 7477 feet.

(4) That there is need for certain extensions to the North Hackberry-Yates Pool, the Henshaw-Wolfcamp Pool, and the Shugart Pool, all in Eddy County, New Mexico, the Milnesand-San Andres Pool in Roosevelt County, New Mexico, the Bronco-Wolfcamp Pool, the Elliott-Abo Pool, the Monument-McKee Gas Pool, the Pearl-Queen Pool, the Vacuum-Queen Pool, and the Vacuum Grayburg-San Andres Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the proposed creation of a new pool in Chaves County, New Mexico, classified as an oil pool for San Andres production, designated as the Diablo-San Andres Pool, consisting of the following described area:

TOWNSHIP 10 SOUTH, RANGE 27 EAST, NMPM SECTION 16: SE/4

is hereby dismissed.

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for Abo production, is hereby created and designated as the Goodwin-Abo Pool, consisting of the following described area:

(c) That the Bronco-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(d) That the Elliott-Abo Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(e) That the Morth Hackberry-Yates Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:
