

OUR FORT WORTH OFFICE HAS REFFERED YOUR LETTER OF NOVEMBER 28, 1962, TO ME FOR HANDLING.

As you have mentioned the unitization of this lease and the Kennedy State No. 2 (NW SE Section 2) with our developed area would be very difficult. We can see no way in which it would be possible.

KENNEDY OIL COMPANY HAS CONTACTED YOUR HOBBS OFFICE REGARDING A UNITIZA-TION OF YOUR WELL WITH HIS SINGLE WELL WHEREIN THE CONVERSION OF HIS WELL TO INJECTION WOULD BE POSSIBLE. WE ARE IN FAVOR OF THIS TYPE ARRANGEMENT DUE TO THE SIMPLICITY OF BEING BETWEEN ONLY TWO OPERATORS, AND NOT INCLUDING THE ACREAGE ALREADY UNDER FLOOD.
