ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m., on February 14, 1963, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 21st day of February, 1963, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool, the Otero-Chacra Pool, the Boulder-Mancos Oil Pool, the Devils Fork-Gallup Pool, and the South Blanco-Tocito Oil Pool, all in Rio Arriba County, New Mexico, the Flora Vista-Mesaverde Pool in San Juan County, New Mexico, the Blanco-Mesaverde Pool and Escrito-Gallup Oil Pool, both in Rio Arriba and San Juan Counties, New Mexico and the South Blanco-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.

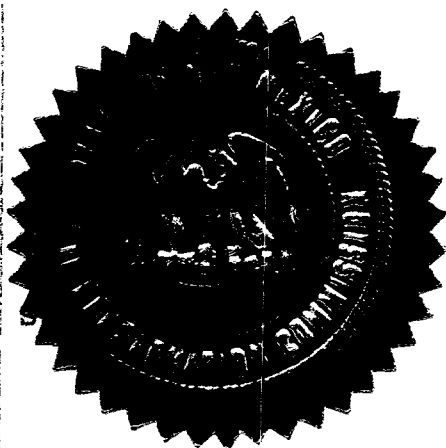
