Gentlemen:

The Commission, at a formal conference held June 10, 1964, considered the above-mentioned application.

The Littman (San Andres) Unit Unitization Agreement, submitted for approval as Exhibit #12, at a hearing held May 20, 1964, was approved effective June 10, 1964; however, for administrative purposes, no amended proration schedule will be issued showing the changed conditions thereon, such as new unit and well designations, until the first (1st) day of July, so that the Proration Department may have time to acquire the necessary data (see enclosure) and to set up and work the new proration schedule.

During the interim period, all operators who have properties committed to the Unit will continue to file Commission required reports on an individual lease basis. When the new schedule has been worked and issued by the Proration Department, the proper unit authority will then file such reports on a unit basis.

Over-production accrued to an individual lease, if any, must either be balanced out by under-production or transferred to the Unit at the time operation of the individual tract under a unitized schedule of allowables and reports is commenced. Any tract having accrued overproduction contrary to this provisions may not be merged into unit operations until the matter is corrected.

The injection program was approved as requested except that Tract 9, Well #1 may not be converted to injection service until 100% of the interests in said tract have been signed to the Unit. It is requested that the proper unit designation for the wells to be used for injection purposes be submitted to the Engineering Department of the Commission as soon as possible, so that they may be included in the formal injection order. If any of the wells to be used for injection Sohio Petroleum Company #2 6/11/64

purposes are converted producing wells, please advise the date such wells will cease to produce oil, so that their allowables may be cancelled.

The Commission also authorized transfer of allowables from wells converted to injection purposes, and authorized expansion of the program without the necessity of further hearing.




