
Gentlemen:

This letter refers to the application of T. J. Sivley for an exception to the no-pit Order No. R-3221 of the Oil Conservation Commission. In this application, I understand that Mr. Sivley seeks authority to continue to dispose of produced water in his unlined surface pit located in the NE/4 SE/4 of Section 28, Township 20 South, Range 34 East, Lea County, New Mexico. I understand that this case has been docketed as No. 3860 and set for hearing on September 18, 1968, before the Oil Conservation Commission.

I am the owner of the ranch in Lea County, New Mexico, embracing Mr. Sivley's Silver Federal Lease. I am familiar with Mr. Sivley's practice in disposing of his produced water in the above mentioned surface pit.

I do not believe that the disposal of water produced by T. J. Sivley, in conjunction with the production of oil from his wells in the Lynch Yates-Seven Rivers Pool, Lea County, New Mexico, constitutes a hazard to the fresh water wells in the area and located on my ranch. Accordingly, you are advised that I have no objection to the proposed application of T. J. Sivley for permission to continue to dispose of his produced water in the above mentioned unlined pit.
