IN THE MATTER OF DIVISION CASE NO. 4826 BEING REOPENED PURSUANT TO THE PROVISIONS OF DIVISION ORDER NO. R-4407, WHICH ORDER CREATED AND PROMULGATED TEMPORARY SPECIAL RULES AND REGULATIONS FOR THE CATCLAW DRAW-STRAWN GAS POOL, EDDY COUNTY, NEW MEXICO.

### ORDER OF THE DIVISION

#### BY THE DIVISION:

This cause came on for hearing at 8 a.m. on August 28, 1985, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 27th day of September, 1985, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

## FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) By Order No. R-4407, dated September 27, 1972, the Division created, defined, and classified the Catclaw Draw-Strawn Gas Pool, Eddy County, New Mexico, and Temporary Special Rules and Regulations were promulgated therefor, including a provision for 640-acre spacing and proration units.
- (3) Pursuant to the provisions of said Order No. R-4407, this case was reopened to allow the operators in the subject pool to appear and show cause why the Catclaw Draw-Strawn Gas Pool should not be developed on 320-acre spacing and proration units.

Case No. 4826 (Reopened) Order No. R-4407-A

- (4) Since the inception of the Catclaw Draw-Strawn Gas Pool, only one well has produced from the pool, the Hanagan Petroleum Corporation Catclaw Draw Unit Well No. 3 located 920 feet from the North and West lines of Section 36, Township 21 South, Range 25 East, NMPM, Eddy County, New Mexico, which was also the discovery well for the subject pool.
- (5) Said well produced from the Strawn formation between October, 1972 and February, 1974 and was plugged and abandoned in July, 1976.
- (6) At the time of the hearing there were no appearances by interested or affected parties.
- (7) It is not known at this time whether additional wells will be completed in the subject pool.
- (8) In the absence of additional testimony showing why the Catclaw Draw-Strawn Gas Pool should not be developed on 320-acre spacing and proration units, the Temporary Special Rules and Regulations promulgated by Division Order No. R-4407 should be rescinded and said pool should be governed by the Statewide Rules.

#### IT IS THEREFORE ORDERED THAT:

- (1) The Temporary Special Rules and Regulations for the Catclaw Draw-Strawn Gas Pool, promulgated by Division Order No. R-4407, dated September 27, 1972, are hereby rescinded and the pool is hereby placed under the Statewide Rules.
- (2) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
