Gentlemen:

The Stock Unit agreement was approved on February 1, 1974, effective as of the date of approval. The term of the agreement is contingent upon the unit operator continue drilling diligently, one well at a time, allowing not more than 120 days between the completion of one well and the beginning of the next well, until a well capable of producing unitized substances in paying quantities is completed.

Our records show the first test well was completed as a dry hole on August 24, 1974. The second test well was due to be commenced by December 24, 1974. Inasmuch as the second test well was not commenced, the Stock unit agreement is considered to have terminated automatically as of December 24, 1974.

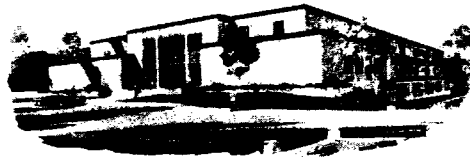

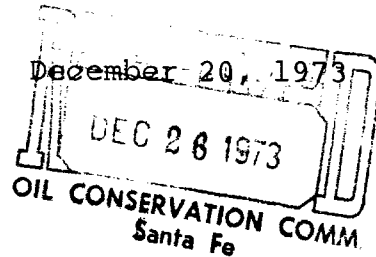
