10 regarding the nomenclature in Lea County, New Mexico, in
11 accordance with the exhibit?

12 A. That seems to be debatable at the present
13 moment. I don't know what all this stuff is in here.

16 minutes and review that, Mr. Johnson?

17 MR. STOVALL: Off the record.

18 (Discussion off the record.)

19 MR. STOVALL: Back on the record.

20 Q. (By Mr. Stovall) Have you now had the
21 opportunity to examine the file, and are you prepared to
22 make the recommendations I asked you about a minute ago?

23 A. I am.

24 Q. And you're recommending the assignment of
25 discovery allowable in the South Shoe Bar-Wolfcamp Pool?

1 A. Yes, sir, I am.

2 Q. Have you examined Exhibit No. 1, and are you
3 prepared to testify as to its accuracy?

4 A. Yes.

5 MR. STOVALL: I have nothing further to add in this
6 case, and I move the admission of Exhibit No. 1.

7 EXAMINER CATANACH: Exhibit 1 will be admitted into
8 evidence.

9 (Whereupon Exhibit 1 was admitted into evidence.)

10 EXAMINER CATANACH: Any questions of this witness?

11 If not, he may be excused.

12 Anything further in this case? There being
13 nothing, Case 10291 will be taken under advisement.
