Gentlemen:

Collins & Ware, Anadarko Petroleum Corporation, and Wilson & Elliott propose to drill a 13,850-foot Morrow test to be located in the NW/4 NE/4 of Section 13, T2OS-R33E. The N/2 of Section 13 shall be the designated proration unit for Pennsylvanian gas production. Our estimated dryhole cost is  $\frac{672,400}{2}$ , and completed producer is estimated at  $\frac{1,069,180}{2}$ .

By virtue of your working interest ownership via the Mahaffey Deep Working Interest Unit Operating Agreement dated 3-15-62, covering the SW/4 NW/4 of Section 13, each of you would have a proportionately reduced working interest in our proposed test well proration unit described in Exhibit "A" attached hereto.

The well proposed herein is subject to that certain Operating Agreement dated March 15, 1962, as amended. Refer to Paragraph 12, "Operations By Less Than All Parties" (this is a 1956 agreement form). You shall have thirty (30) days from receipt of this proposal to notify Collins & Ware, Inc., of your election to join in the drilling of the test well; and, in lieu of going non-consent, we request that you either sell your interest or farmout your interest on the same basis as Scope Energy Resources, Inc., whereby delivering a 75% net revenue interest before payout, convertible to a 20% backin working interest after payout.

I will be forwarding to each of you the Teas Operating Agreement for your execution. The parties to the March 15, 1962 Operating Agreement shall designate Collins & Ware, Inc., as Operator covering the SW/4 NW/4 of Section 13 only, and, as long as the SW/4 NW/4 acreage is dedicated to the established 320-acre proration unit. At the expiration of the Teas Operating Agreement, the SW/4 NW/4

shall automatically revert back to the terms and conditions of that certain Operating Agreement dated March 13, 1962.
