FINDS THAT:


- (1) Case No. 10345, the application of BHP Petroleum (Americas), Inc. for compulsory pooling, was originally heard before an examiner on July 25, 1991. Division Order No. R-9581 was entered on September 11, 1991, as a result of said examiner hearing. A De Novo application was timely filed by Louise Y. Locke d/b/a Locke-Taylor Drilling Company, and a De Novo hearing was held before the Oil Conservation Commission on March 12, 1992. Commission Order No. R-9581-A was entered on June 29, 1992, as a result of said De Novo hearing. On September 15, 1992, Louise Y. Locke submitted an objection to the well costs and said Case No. 10345 was reopened and docketed for hearing before the Commission on January 14, 1993.
- (2) After requesting and being granted several continuances, Louise Y. Locke has now requested dismissal of the reopened case and such request should be granted.
