

Harvey E. Yates Company (HEYCO) proposes the drilling of the Atlantic 32 State #4 well to be located at a legal location in the SE/4 NW/4 of Section 32, T-18S, R-33E, Lea County, New Mexico. Said well will be drilled to a depth of 4,560', or to a depth sufficient to test the Queen and the Penrose formations. We anticipate spudding this well sometime within the next two weeks.

The #4 location is a south offset to the Atlantic 32 State #1, the discovery well for the Buffalo Queen field, which has produced 29 MBO since recompletion in the Queen/Penrose sand in November, 1990. The #1 Well produced 159 BOPD in July, 1991, and should produce 190 MBO before depletion.

The #2 well, drilled in May, 1991, is 700' southwest of this new location and is also completed in the Queen/Penrose. It is capable of pumping 70-80 BOPD.

We have enclosed two copies of the AFE, (revised from the AFE we sent you in our August 9, 1991 letter) which lists approximate costs of \$140,711 for a dry hole and \$345,056 for a producing well. Please return one signed copy of the AFE to our office at your very earliest convenience.
