Amoco Production Company, as an offset operator in this matter, hereby **objects** to the application of Chevron for an unorthodox gas well location at 2070' FSL and 1970' FEL of Section 22, T-21-S, R-36-E, Lea County, New Mexico, and to the simultaneous dedication of acreage consisting of the E/2 and the SW/4 of Section 22, T-21-S, R-36-E, Lea County.

We believe that the multiple well unit consisting of the 480 acres as described above should be classified marginal since its highest monthly production was less than the average allowable allocation during the December-March classification period and it was underproduced. However, it has been carried as non-marginal on the gas proration schedule.
