

1. Applicant is the operator of the NW/4 of Section 27, Township 13 South, Range 29 East, N.M.P.M., Chaves County, New Mexico, and proposes to drill its McClellan Federal No. 6 Well at an unorthodox location 990 feet from the North line and 330 feet from the West line of said Section 27.


2. Applicant seeks an exception to the well location requirements of Division Rule 104 to permit the drilling of a well at the above-described unorthodox location to an approximate depth of 10,000 feet to adequately test the Devonian formation, South Lone Wolf-Devonian Pool.

3. Approval of this application will afford applicant the opportunity to produce its just and equitable share of hydrocarbons underlying this spacing unit and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant prays that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on September 19, 1991 and, that after notice and hearing as required by law, the Division enter its order granting this application and providing such other relief as is proper.




