Dear Mr. Bohling:

Reference is made to your application dated July 7, 1992 for an unorthodox Eumont gas well location in an existing non-standard 400-acre gas spacing and proration unit (GPU) for said Eumont Gas Pool comprising the SW/4 of Section 1 and the NE/4 and E/2 NW/4 of Section 12, all in Township 22 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. R-1084-C, dated November 4, 1991 and presently has dedicated thereon the H.T. Mattern (NCT-E) Well Nos. 10 and 11 located respectively in Unit N of said Section 1 and Unit B of said Section 12.

It is our understanding that the subject well in this application is currently completed as a producing well in the Drinkard Pool; however, said well will be plugged back to the Eumont Gas Pool upon issuance of this order.

By the authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox gas well location is hereby approved.

H.T. Mattern (NCT-E) Well No. 13 2310' FNL - 330' FEL (Unit H) of Section 12 Chevron U.S.A. Inc.
