

 In the matter of the hearing called by the Oil Conservation Division on its own motion for an order creating and extending certain pools in Chaves and Eddy Counties, New Mexico.

- (a) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Upper Pennsylvanian production and designated as the Parkway-Upper Pennsylvanian Pool. The discovery well is the Yates Petroleum Corporation Wayfarer A1Y State Well No. 1 located in Unit P of Section 25, Township 19 South, Range 29 East, NMPM. Said pool would comprise:
