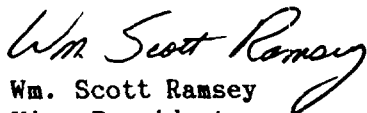
Gentlemen:

This letter is to advise you that Hal J. Rasmussen Operating, Inc. has filed an application with the New Mexico Oil Conservation Division seeking the promulgation of Special Pool Rules for the Wilson Yates-Seven Rivers Oil Pool located in Township 21 South, Ranges 34 and 35 East, N.M.P.M., Lea County, New Mexico. Hal J. Rasmussen Operating, Inc. seeks the promulgation of Special Pool Rules to provide for 160-acre gas spacing units, 40-acre oil spacing or proration units, a gas-oil ratio of 10,000 to 1 and provisions for administrative approval by the District Supervisor of non-standard spacing or proration units in the pool.

This application has been set for hearing before an Examiner of the Oil Conservation Division on January 9, 1992. You are not required to attend this hearing, but as the owner of an interest within the pool or within a mile thereof who may be affected by this application, you may appear at that time and present testimony. Failure to appear and become a party of record in this case will preclude you from challenging this application at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
