ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at _____ a.m. _____ 1992,
at Santa Fe, New Mexico, before Examiner _____.

NOW, on this _____ day of January, 1992, the Division
Director, having considered the testimony, the record, the
recommendations of the Examiner, and being fully advised in
the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law,
the Division has jurisdiction of this cause and subject
matter thereof.
- (2) There is need for the creation of a new pool in Eddy
County, New Mexico, for the production of oil from the
Bone Spring formation. Said pool to bear the
designation of Cedar Canyon-Bone Spring Pool. Said
Cedar Canyon-Bone Spring Pool was discovered by Vision
Energy Inc., H.B. 3 Fed. #1, located in Unit J of
Section 3, Township 24 South, Range 29 East, NMPM. It
was completed on October 7, 1991 in the Bone Spring
formation. The top of perforations is at 7,863 ft.

In addition, a discovery allowable of 39,315
barrels of oil is assigned to this well. The
discovery allowable is to be produced over a
period of 2 years and is over and above the
daily allowable.

(3) *Creation of North Santo Nino - Upper Pennsylvanian Pool*
should be dismissed.

(4) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation. Said pool to bear the designation of Tansill Dam-Atoka Gas Pool. Said Tansill Dam-Atoka Gas Pool was discovered by Bird Creek Resources, Jarvis Mead Com #1, located in Unit N of Section 5, Township 22 South, Range 27 East, NMPM. It was completed November 2, 1991 in the Atoka formation. The top of perforations is at 10,423 ft.

(5) There is need for certain extensions to the West Pecos Slope-Abo Gas Pool in Chaves County, New Mexico and to the Burton-Delaware Pool, Crozier Bluff-Atoka Gas Pool, South Culebra Bluff-Bone Spring Pool, Livingston Ridge-Delaware Pool, Lost Tank-Delaware Pool, East Millman-Queen/Grayburg/ San Andres Pool, Parkway-Delaware Pool, Salt Draw-Atoka Gas Pool, and the Shugart-Yates/Seven Rivers/Queen/Grayburg Pool all in Eddy County, New Mexico.

IT IS THEREFORE ORDERED:

(a) Create a new pool in Eddy County, New Mexico, classified as an oil pool for Bone Spring production and designated as the Cedar Canyon-Bone Spring Pool. The discovery well is the Vision Energy, H.B. 3 Fed #1 located in Unit J of Section 3, Township 24 South, Range 29 East, NMPM. Said pool would comprise:

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be _____.
