

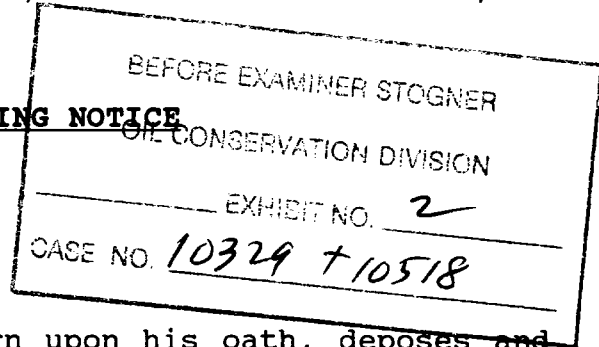

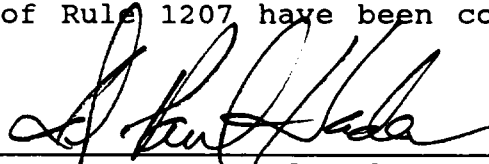

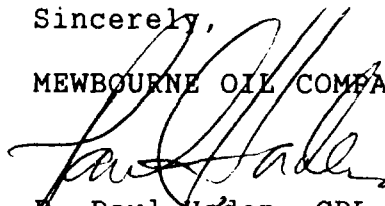
Ladies and Gentlemen:

**APPLICATION AND MOTION
FOR CONTINUANCE**

Mewbourne Oil Company, for its application and motion, states:

1. Applicant owns working interests and operates wells in the Cedar Lake-Strawn Pool, or within one mile thereof.

2. The Cedar Lake-Strawn Pool was created by Division Order No. R-9545, and special pool rules (including 80 acre spacing) were instituted under Division Order No. R-9554 (Case No. 10329). Case No. 10329 (reopened) is scheduled for hearing on July 23, 1992.

3. Mewbourne seeks to amend Order No. R-9554 for wells completed in said pool, or for wells completed or recompleted as Strawn oil wells within one mile thereof, to provide for:

(a) 160 acre oil well spacing, with a standard unit consisting of a governmental quarter section;

(b) A gas:oil ration of 4000:1; and

(c) Well location requirements such that each well shall be located no nearer than 660 feet to the outer boundary of the proration unit nor nearer than 330 feet to any governmental quarter-quarter section line, nor closer than 1,320 feet to the nearest well drilling or capable of producing from the Cedar Lake-Strawn Pool.

Applicant requests that all other pool rules be in conformance with Division statewide rules.

4. Mewbourne requests that this matter be heard at the August 6, 1992 hearing, and that Case No. 10329 (reopened) be continued until August 6, 1992 so that both cases may be heard together.

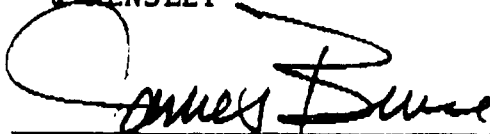
5. This application is in the interests of conservation and the prevention of waste.
